

Quincy University Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) and American Rescue Plan Act, 2021 (ARP) Reporting as of September 30, 2021:

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

Quincy University accepted the agreement of the Coronavirus Response and Relief Supplemental Appropriations Act funds by drawing them down from the Department of Education's G5 site on April 5, 2021.

Quincy University accepted the agreement of the American Rescue Plan Act funds by drawing them down from the Department of Education's G5 site on August 5, 2021.

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

Quincy University received \$520,696 from the U.S. Department of Education to provide Emergency Financial Aid Grants to students under CRRSAA.

Quincy University received \$1,483,813 from the U.S. Department of Education to provide Emergency Financial Aid Grants to students under ARP.

3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as (i.e., as of the 30-day Report and every 45 days thereafter).

As of September 30, 2021 the total amount of Emergency Financial Aid Grants distributed to Quincy University students under the CRRSAA (a)(1) and (a)(4) programs is \$520,696.

As of September 30, 2021 the total amount of Emergency Financial Aid Grants distributed to Quincy University students under the ARP (a)(1) and (a)(4) programs is \$1,483,813.

As of September 30, 2021 630 Quincy University students have received an Emergency Financial Aid Grant to students under the CRRSAA.

As of September 30, 2021 905 Quincy University students have received an Emergency Financial Aid Grant to students under the ARP

Quincy University undergraduate students were awarded Emergency Financial Aid grants under the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) 2021 based on need as determined by the EFC. Students must have filed a 2020-2021 Free Application for Federal Student Aid (FAFSA) and have a valid Expected Family Contribution (EFC) of less than \$44,360, as well as completed the federal verification process, if selected to be considered for Emergency Financial Aid grants under this funding. Award amounts are as follows-

Quincy University undergraduate students who were registered as of August 5, 2021 were awarded Emergency Financial Aid grants under the American Rescue Plan Act, 2021 (ARP) based on need as determined by the EFC. All undergraduate students qualified for Emergency Financial Aid grants, with larger grant awards given to those who demonstrated the most need as determined by the EFC on the 2021-2022 FAFSA. Students receiving Emergency Financial Aid Grants under the CRRSAA received the following email on April 1, 2021-

Quincy University will be distributing CARES Act funds to undergraduate students who were registered in the spring semester as of March 31, 2021. These funds are being awarded as part of the Consolidated Appropriations Act, 2021 that was signed into law on December 27, 2020. To be eligible for this round of CARES funds, you must have filed a Free Application for Federal Student Aid (FAFSA) and have a valid Expected Family Contribution (EFC) of less than \$44,360, as well as completed the federal verification process, if selected. The purpose of the CARES Act funds is to assist students with their educational expenses, such as tuition, food, housing, technology needs, health care and childcare, during the COVID-19 pandemic. Students receiving this email have been awarded CARES Act funds.

CARES Act checks will be available for pick beginning Monday, April 5 in Student Financial Services, Francis Hall, Room 104, with your student ID. All checks must be picked up in Student Financial Services at this time, NO checks will be mailed. Please note, if you elected to have your CARES funds applied to your student account, you may not have a check available for pick up. Please check your student account on the student portal for details.
